Training Programs

Geriatric Counselling (

The President of Annai Foundation, Mr. Alexander, and staff member Mrs. Kalaiselvi, participated on behalf of our Annai Foundation in the three-day Residential Training Program on Geriatric Counselling offered by the National Institute of Social Defence (NISD). During this three-day training, experts from various fields such as the Fire Service Department, Health Department, Yoga, nutrition, and speech provided training sessions.

The program was offered by the National Institute of Social Defence (NISD). The training covered multiple disciplines, with sessions delivered by specialists from:

- Fire Service Department
- Health Department
- Yoga
- Nutrition
- Speech

The participation in this specialized training is expected to enhance the foundation's capacity to provide effective counselling and support for the elderly.

Ongoing Projects

Women Group

In order to support the advancement of rural women and their economic empowerment, awareness was created in rural areas regarding how they can start small businesses, and how they can function as a women's group (Mahalir Kuzhu) to manufacture and sell handicrafts and food products. Rural women's self-help groups (SHGs) were invited, and a resolution was also passed to help them secure bank loans with subsidies to start their businesses.

An awareness campaign was conducted in rural areas to support the advancement and economic empowerment of women. The initiative focused on encouraging women to start small businesses and function as Women's Groups (Mahalir Kuzhu) for the production and sale of handicrafts and food products.

Key decisions and actions include Awareness Creation, Invitation, and also Resolution Passed. This initiative aims to improve the livelihoods of rural women by providing them with the necessary knowledge and financial support to become entrepreneurs. Final major output discussion was "Promoting Economic Empowerment and Small Businesses for Rural Women".

Annai Children's Home (

The Annai Children's Home, established by the Annai Foundation for orphaned and destitute children, has been officially registered under the Government Social Welfare Department. The facility is located at A. Kuchipalayam, KeezhArungunam Panchayat, Panruti Taluk, Cuddalore District.

The inauguration ceremony was a notable event. It was presided over by Mr. R. Alexander, President of the Annai Foundation. Mr. R. Sundar, B.Sc., B.L., the District Child Protection Officer - Cuddalore, was also present.





The home was formally inaugurated by Dr. M. K. Vishnu Prasad M.B.B.S, the Honorable Member of Parliament for Cuddalore. This new facility marks a significant step by the Annai Foundation to provide a safe and supportive environment for children in need within the Cuddalore District.

Medical Camp

Outreach Activities

Flood Relief - 1

Due to the heavy rainfall and subsequent flooding caused by Cyclone Fengal that hit in December 2024, villages in the Nellikuppam area of Cuddalore District were plunged into darkness. Numerous farmlands, as well as electrical appliances and household goods in homes, were submerged.



Flood Relief activity in Mulligrampattu & Vanapakkam

When the flooding began, particularly in the villages of Mulligramapattu and then Vanpakkam under Nellikuppam Municipality, upon hearing the news, we joined volunteers and immediately arranged for a Van. Working for approximately one hour at night, we safely rescued the children, women, and elderly people there.

Following the rescue, we continued to provide food and relief materials to the people of Vanpakkam and Mulligramapattu. We personally visited the people sheltered in the relief camps to distribute the aid.

Flood Relief - 2

The heavy rain and subsequent flooding caused by the "Fengal Cyclone" (likely a misnomer or local name for a significant weather event like Cyclone Fengal) in December 2024 severely inundated numerous houses in the Nellikuppam area of Cuddalore District. The affected people were rescued and housed in relief camps.

Relief materials were distributed to the flood victims who had lost their homes by the Yasin Trust of C.N. Palayam. This event took place at the Mosque Hall near the Nellikuppam Grand Mosque. We participated as special guests in this event and distributed the relief materials to the affected people.

Residents from the affected, submerged houses were successfully rescued and temporarily relocated to relief camps. The relief distribution provided crucial support to the flood-affected families, helping them recover from the impact of the disaster.




This certificate of Registration is awarded to <u>Annai Children Home</u> as an institution for children in need of care and protection vide 1591/psp/JJR/cup/2024 under section 41(1) of the Juvenile Justice (Care and Protection of Children) Act, 2015. This certificate of registration is valid for 16/12/2024 - 16/12/2029 from the date of issue and is subject to the following conditions:-

- I. The Management should run the institution in accordance with Juvenile Justice (Care and Protection of Children) Act, 2015
- 2. Based on the infrastructure available at present the institution shall admit a maximum of 9 (Boys 9) (Girls 0) children only
- 3. The Management of the Child Care Institution should always maintain the required staff 7 as per the sanctioned strength approved
- 4. This certificate should be displayed prominently for the information of parents/general public in the office room.
- 5. The following words may be mentioned in the name board of the institution. <u>Annal Children Home</u> is registered by the State Government under Juvenile Justice (Care and Protection of Children) Act 2015.
- 6. The services to the children shall be provided by the institutions registered under the Act as per section 53 of Juvenile Justice (Care and Protection of Children) Act, 2015.
- 7. The institution shall have a Management Committee in accordance with these Rules to manage the institution and monitor the progress of every child.
- 8. Institution should follow rules / regulations issued by State Government / Director/Commissioner of Children Welfare and Special Services from time to time.
- 9. The Institution is subject to inspection by the inspection authorities under the Act and by the persons / officers authorized by the State Government /
 District Child Protection Society / Child Welfare Committee
- Orders should be obtained from Child Welfare Committees for all admissions and discharge
- II. Any admission / death / repatriation of the children in the institution and any discharge of children from the institution should be intimated to the concerned District Child Protection Officer and Child Welfare Committee in accordance with Tamil Nadu Juvenile Justice (Care and Protection of Children) Rules, 2017.
- 12. The registration certificate is valid for the period mentioned therein and is subject to the condition that all the required certificates / NOC are renewed in time before expiry and a copy has to be furnished to the District Child Protection Officer of concerned District and to the Directorate of Children Welfare and Special Services
- 13. The Institution should provide proper infra-structure facilities including sufficient accommodation to children.
- 14. To ensure proper education, child rights and necessary safeguards from child abuses.
- 15. To provide health facilities, toilet facilities and bathroom facilities
- 16. To ensure water and sanitation and also safe drinking water.
